1. Qualitative Information on the Interim Financial Results

(1) Explanation of Operating Results

During the consolidated interim accounting period (April 1, 2025 to September 30, 2025), the global economy continued on a moderate recovery path. However, the impact of U.S. trade policies became evident, particularly in the automotive industry, and rising international uncertainties led to a general slowdown in the pace of growth. In the United States, personal consumption remained resilient, supported by a robust labor market and rising wages. However, continued attention is required regarding the trends in tariff policies and the impact of monetary tightening. In Europe, the prolonged slump in the manufacturing sector has resulted in a lackluster economic recovery. In China, although government stimulus measures have provided some level of support, the ongoing adjustment in the real estate market has led to a slow pace of recovery.

In the automotive industry, the reassessment of electrification strategies is accelerating. Due to the revision of subsidy policies in major markets and delays in the development of charging infrastructure, the growth in demand for battery electric vehicles (BEVs) continues to slow. On the other hand, global demand for HEVs (hybrid electric vehicles) is expanding, and automakers are strengthening their powertrain portfolio strategies to meet market needs, including BEVs, HEVs, and PHEVs (plug-in hybrid electric vehicles). In addition, the impact of increased tariffs continues in certain countries and regions, such as the United States, prompting OEMs to accelerate efforts to optimize their production and supply systems.

Our group is actively working to strengthen its management foundation in response to changes in the business environment, such as geopolitical risks and revisions to tariff policies. In our core business, orders for key products such as differential assemblies, as well as components used in BEVs and HEVs, have remained strong. In the Chinese market, we are seeing progress in expanding orders from local OEM manufacturers and are working to build a foundation for medium- to long-term growth. Meanwhile, in Europe, where the manufacturing sector continues to stagnate, we are promoting structural reforms. Through the consolidation of production sites and optimization of fixed costs, we aim to transform our business structure to ensure profitability even under challenging market conditions.

In the new business area, particularly in the Energy Solution segment, we are establishing a production system to scale up the production capacity of hybrid supercapacitors (HSCs), which are experiencing rapidly growing demand for use in AI data centers. To further accelerate business growth, in July we transitioned the Energy Solution business to a function-based organizational management structure. In the e-Mobility business, following our initiatives in Kenya, we are also promoting the adoption of two-wheeled EVs in Ethiopia. In Bangladesh, we have initiated collaboration with startup companies, further accelerating our business expansion in emerging markets.

Under these circumstances, consolidated net sales during the interim period under review amounted to 168,545 million yen (down 2.8% year-on-year). In terms of profitability, consolidated operating profit was 8,498 million yen (up 8.4% year-on-year). Consolidated ordinary income was 7,964 million yen (up 27.4% year-on-year), and the interim net income attributable to owners of the parent was 4,332 million yen (up 45.8% year-on-year).

The business performance by segment is as follows:

(Japan)

Although sales remained solid, upfront investment costs in the Energy Solution business increased. As a result, net sales totaled 19,302 million yen (up 3.9% year on year) and segment profit was 728 million yen (down 36.4% year on year).

(Americas)

Sales continued to be strong since last year. However, due to the upfront investment costs in the Energy Solution business, net sales totaled 54,735 million yen (up 5.4% year on year) and segment profit was 2,673 million yen (down 5.3% year on year).

(Asia)

Sales for two-wheeled vehicles remained solid. However, due to the impact of foreign exchange rates, net sales totaled 38,196 million yen (down 5.6% year on year) and segment profit was 4,218 million yen (down 0.6% year on year).

(China)

While the downturn in Japanese-brand vehicle sales continued, thorough cost management efforts were implemented. As a result, net sales totaled 14,151 million yen (down 4.2% year on year) and segment profit was 217 million yen (a loss of 322 million yen in the same period of the previous fiscal year).

(Europe)

Amid the overall slump in the automobile market, the Company continued to promote cost management and other improvement measures. As a result, net sales totaled 42,158 million yen (down 11.6% year on year) and segment profit was 652 million yen (a profit of 15 million yen in the same period of the previous fiscal year).

(2) Explanation of Financial Position

1. Assets, Liabilities and Net Assets

Total assets increased by 9,279 million yen from the end of the previous fiscal year to 294,406 million yen.

Current assets increased by 4,571 million yen from the end of the previous fiscal year to 151,479 million yen.

This was mainly due to an increase in cash and deposits.

Fixed assets increased by 4,708 million yen from the end of the previous fiscal year to 142,926 yen. This was mainly due to an increase in construction in progress.

Liabilities increased by 5,295 million yen from the end of the previous fiscal year to 166,452 million yen. This was mainly due to an increase in short-term borrowings.

Net assets including non-controlling interests increased by 3,984 million yen from the end of the previous fiscal year to 127,954 million yen.

2. Cash Flows

During the interim consolidated accounting period, net cash provided by operating activities amounted to 16,908 million yen. The main factors contributing to the increase in cash were net income before income taxes and depreciation. The primary factors contributing to the decrease in cash were an increase in inventories and a decrease in trade payables.

Net cash used in investing activities totaled 11,193 million yen, mainly due to expenditures for the acquisition of property, plant, and equipment.

Net cash used as a result of financing activities totaled 2,663 million yen. This was mainly attributable to the payment of dividends.

As a result, cash and cash equivalents at the end of the current interim accounting period amounted to 37,583 million yen.

(Significant Changes in Scope of Consolidation)

Musashi Energy Solutions North America, Inc., newly established during the first quarter of the consolidated accounting period, has been included in the scope of consolidation.

(Changes in Matters Related to Fiscal Year of Consolidated Subsidiaries)

Musashi Wired Co., Ltd., a consolidated subsidiary whose fiscal year-end had traditionally been February 28, previously prepared its financial statements as of that date and made necessary consolidation adjustments for significant transactions occurring between that date and the consolidated fiscal year-end. However, starting from the first quarter of the current consolidated accounting period, the fiscal year-end has been changed to March 31. Accordingly, the profit and loss for the period from March 1 to March 31, 2025, has been adjusted as a change in retained earnings. The impact of this change on the consolidated financial statements is immaterial.

(Application of Accounting Methods Specific to the Preparation of the Interim Consolidated Financial Statements)

(Calculation of Tax Expense)

The Company and its domestic consolidated subsidiaries estimate a reasonable effective tax rate after applying tax effect accounting to profit before income taxes for the current consolidated fiscal year. This estimated effective tax rate is then applied to interim profit before income taxes to calculate income tax expenses.

However, if applying the estimated effective tax rate results in a significantly unreasonable outcome, the statutory effective tax rate is used instead.

(Application of Accounting Treatment and Disclosure Regarding the Global Minimum Tax Regime)

Our group companies have applied Paragraph 7 of the "Accounting Treatment and Disclosure Regarding Corporate Income Taxes under the Global Minimum Tax Regime" (Accounting Practice Response No. 46, issued on March 22, 2024), and has not recognized corporate income taxes related to the international minimum tax amount for the fiscal year including this interim consolidated accounting period.

2. Information on Impairment Losses or Goodwill on Fixed Assets by Reporting Segment

In the "Japan" segment, the Company acquired 60% of the shares of Wired Inc. on April 26, 2024. As a result of this transaction, goodwill increased by 353 million yen during the previous interim consolidated accounting period.

The amount of goodwill is final, as the identification of identifiable assets and liabilities, the determination of their fair values, and the allocation of the acquisition cost have been completed.
